

(This script is based on the William vs Saxbe Supreme Court case, which was a landmark case against sexual harassment in the workplace.)

Setting: Meritor Bank

Date: 1974

Characters: Menche Wilson

Sydney Taylor

Backstory: Menche Wilson comes into work at Meritor Savings Banks as a teller-trainee, when a man by the name of Sydney Taylor comes in.

Sydney Taylor: Hello Ms. Wilson!

Menche Wilson: Hello Mr. Sydney!

Sydney Taylor: I saw how well you're doing at your job and I would like to give you a promotion.

*Sydney Taylor says this as he gets very close to Menche Wilson and rubs her back.*

Menche Wilson: Th- thank you, sir!

Sydney Taylor: Yes keep up the good work and there will be more promotions and benefits.

*1 month later*

*It is seen that Sydney Taylor is giving "special attention" to the other female employees and is starting to violate their personal space*

*Menche Wilson is called into Sydney Taylor's office*

Sydney Taylor: Hello, Ms. Wilson, I called you in my office today is because that it seems you are doing less and less work. You are taking more and more sick leaves. Has the benefits and promotions not been enough?

*Sydney Taylor gets closer to Menche and starts rubbing her shoulders without her asking.*

Sydney Taylor: It seems you will need to give me *more reasons why I should let you keep your job.*

*Sydney Taylor looks at Menche in an "unprofessional" manner*

Menche Wilson: Y-yes boss, just don't fire me

Sydney Taylor: I won't if you promise me to not do anything against me or say anything.

*4 years pass*

*Menche Wilson has been going through rampant sexual harassment while also witnessing her female co-workers go through the same thing.*

*Today Menche Wilson is called into the office of Sydney Taylor*

Menche Wilson: Good Afternoon Mr Taylor, how may I help you today?

Sydney Taylor: I've called you here to discuss your performance, and I must say it is starting to wane down Ms. Wilson.

*After four years of his harassment, Menche Wilson is starting to get sick of it, All of the touching, groping, doing " favors", the lewd stares, the unwanted presence, all of it*

Sydney Taylor: perhaps you can give me a rea-

Menche Wilson: NO

*Sydney Taylor is taken aback by Menche Wilson's response*

*Menche Wilson starts to raise her voice which attracts the other female workers near the office door,*

Menche Wilson: IM TIRED OF YOU AND YOUR RAMPANT SEXUAL HARASSMENT, YOUR TOUCHING, GROPING, COMING INTO MY PERSONAL SPACE AND ALL OF IT!!

Sydney Taylor: Lower your voice this instant or else.

*The woman at the bank gather around Sydney Taylor's office.*

Menche Wilson: I don't care, im going to report you to the higher ups!

Sydney Taylor: Menche Wllson you're fired!

Menche Wilson: I'd rather be fired than work with a lecherous person than you. Wait ti'll you hear from my lawyers about your unjust firing!

*A couple years pass & within those years Menche Wilson files her complaint to the board of directors which then goes straight to the supreme court for whether or not quid pro quo sexual harassment is a form of gender discrimination in the workplace. And now this case has decreased the amount of terminations in the workplace for people who refuse to be sexually harassed by their superiors.*
